Colorado Charitable Solicitations Act Title 6, Article 6, C.R.S.

Every charity that intends to solicit contributions in Colorado needs to file a registration statement and a financial report with the Secretary of State.

Registrations must be renewed on or before the **15th day of the eighth calendar month** after the close of each fiscal year. Same deadline applies to updating estimated financials with actual financial information.

You can file a three-month extension online, but this needs to be filed before your due date. In practice, we give 17 extra days after a registration expires, but after that, your registration will need to reinstated, not simply renewed.

Login Difficulties?

- Is the person who did this before no longer with the organization? Email <u>charitable@coloradosos.gov</u> to add new authorized officer and delete the old one.
- 2. Email address not recognized when you log in? You might have *subscribed to email notifications* regarding an organization's filings using one email address but requested a login for Charities filings using a different email address. If your email address is not recognized, email <u>charitable@coloradosos.gov</u> to update or confirm.
- 3. Reminder if this applies, an authorized officer of the charity needs to be the one to add a preparer as a user.



Who Can Be the Authorized Officer?

8 CCR 1505-9, Rule 1.3

This individual must be an officer of a nonprofit corporation, a trustee of a charitable trust, or a senior manager member of any other entity that needs to register.



How to Login and Sign

You use a preparer, and they ask you to view and sign a filing. How do you do that?

Log in to your account on the Charities and Fundraisers page. You will be directed to your dashboard, which consists of three main sections:

- (1) My Organizations
- (2) Open Filings
- (3) Filings due in the next 30 days (including past due filings).

Under Open Filings, select the appropriate link in the "Filing" column. Click on "View Filing" and review. Then click on the Back button and click on "Sign Filing." The preparer will get an email informing them that you signed the document.



Email Reminders - Which Filing is This?

Charities Program

- Registration Statement (location, mission, leadership)
- Financial Statements
- Renewals due on or before 15th day of eighth month after the fiscal year ends

Business Organizations Program

- Articles of Incorporation or Statement of Foreign Entity Authority
- Periodic Reports Due search Business database for your org, find reporting month

Your renewal is due soon.

Organizations that provided estimated figures in their initial registration will need to amend the initial filing to update estimates with actual financial information before they can file a renewal. Failure to renew or request an extension of the deadline with our office may result in late fees.

The charitable solicitations registration renewal is different and separate from the periodic report filed with the Business Organizations Program.

The Periodic Report for BUSINESS NAME - Business ID is due.

You must file a periodic report annually to keep your entity in Good Standing. If you don't file on time, you will need to pay a late fee. Due dates and any fees or penalties are automatic and statutorily applied. As such, due dates and fees cannot be altered or waived.

Seasoned customer?

To file now, or any time during your report month, go to the entity <u>Summary</u> and click on "File a form" near the bottom of the page.

No longer operating this business?

See information and instructions on how to dissolve your business, or withdraw, whichever is appropriate.

Tips About the Financial Report

- All applicants must complete the SOS financial report, even if they filed an IRS Form 990-N.
- Audited financial statements are not required in CO.
- \$0 revenue and \$0 expenses reported for an established organization. If this is indeed accurate (vs. the financials are not ready yet), email <u>charitable@coloradosos.gov</u> ahead of time to explain.
- \$0 in fundraising expenses despite significant contributions revenue is unusual, looks like an improper allocation of expenses.



Street Addresses Required

The principal place of business for the charity needs to be a street address. Same principle applies to custodian of financial records, and any office addresses in Colorado.

A post office box or private mailbox can be listed as a mailing address.



Important Dates for Calendar-year Organizations

May 15 – renewal due to SOS if IRS did not approve an extension for the Form 990.

- Aug. 15 renewal due to SOS if IRS approved an extension for the Form 990.
- Aug. 16 registration is expired, organization can no longer solicit contributions legally.
- Sept. 1 last day you can request an extension of due date to Nov. 15. Filing the extension will return the organization to Good status.
- Oct. 31 reminders emailed re: Nov. 15 due date.
- Nov. 16 registration expired, so organization must reinstate and pay a fine to solicit contributions legally.



Reinstate Expired Registration

- Organization may need to submit multiple financial reports when it reinstates
- Only select years for which you can file a financial report <u>today</u>
- If necessary, can file an extension request after the reinstatement process is completed, but must do so <u>within five</u> <u>days</u> of SOS approval.
